I shall not place or cause to be placed in or upon any ditch or watercourse within the Town any manure, nightsoil, dirt, offal or offensive substance, or any glass, stone wood, metal or rubbish tending to impede the flow of water in such ditch or watercourse and will adhere to all regulations of By-law No. 24.

I acknowledge my understanding that the foregoing is an application only, and until a building permit has been received by me, no part of the intended work shall be undertaken.

I am aware of the requirements of the Building By-Law and the Zoning By-law as they pertain to my intended work. I am also aware that this permit expires one year from date of application and all exterior work must be completed within one year of date of application (i.e. siding, entrance ways, windows, roofing, etc...).

I undertake to carry out the intended work in compliance of the Building By-Law, the Zoning By-Law, and any other applicable by-laws of the Town.

Once constructed, I agree to use the structure for the sole purposes indicated in the preceding application.

I understand that if my proposed work in any way does not meet the requirements of the aforementioned by-laws, I must request in writing a variance of the particular by-law from the Planning Advisory Committee. Until such variance has been granted by that body in writing, I will not commence any work.
