



# Canada Day Festivities 2024

## Entertainment Proposal

The very popular event is hosted by the Town of Quispamsis and is visited by thousands on July 1<sup>st</sup>. The festivities have a strong identity and solid local support.

We anticipate that the 2024 activities at the Arts & Culture Park will include giant inflatables, musical entertainment, and much more as we celebrate Canada.

The aim of the performances on the open-air stage is to provide quality, accessible, and family-friendly entertainment for the park's visitors who range in age from infants to seniors.



This year's theme is *Celebrate Canada – Seas the Day* with a pirate flair.

The timeline plan for the day is approximately as follows:

- 11:00 am – Opening Artist's (#1) performance (1 hour)
- 12:00 noon – Artist (#2) performance (1 ¼ hour)
  - 1:15 pm – Welcome Ceremony, O' Canada & Cake Cutting
  - 1:30 pm – Final Artist (#3) performance (1 ¼ hour)
  - 2:45 pm – Farewell (15 minutes)

The budget for the entertainment portion of the event is \$6,750.00, taxes included. The Town of Quispamsis will provide a cheque for 50% to the successful company on June 1st and a cheque for the remainder on July 1st. All fees for sound, artists, the emcee, etc. are to be paid by the company. The stage will be provided by the Town.

The Town of Quispamsis does not by virtue of this quotation call, commit to an award of this proposal, nor does the Town limit itself to accepting the lowest of any proposal submitted, but reserves the right to award this proposal in any manner deemed to be in the Town's best interest.
