



## TOWN OF QUISPAMSIS PUBLIC NOTICE PROPOSED BY-LAW AMENDMENT NO. 036-06; A BY-LAW OF THE MUNICIPALITY OF QUISPAMSIS RESPECTING SIGNS

Public Notice is hereby given that the Quispamsis Town Council intends to consider enacting By-law Amendment No. 036.06; A By-Law Of The Municipality Of Quispamsis Respecting Signs.

The proposed Sign By-law has been updated to include:

• language that restricts signs being placed in "Traffic Control Devices" like a Traffic Roundabouts, Traffic Control Islands, Traffic Circles.

The proposed By-law Amendment No. 036-06 received first and second reading at the April 15, 2025 Regular Meeting and third and final reading will be considered by Council at the May 6, 2025 Regular Meeting which begins at 6:00 p.m., and is held in the council chambers of the Quispamsis Town Hall, 12 Landing Court, Quispamsis, New Brunswick.

The proposed amendment may also be inspected by any interested person during regular office hours, 8:00 a.m. to 4:30 p.m., Monday to Friday inclusive, at the Quispamsis Town Hall, 12 Landing Court, Quispamsis, New Brunswick.

## AMENDMENT NO. 36-06

## TO SIGN BY-LAW NO. 036 A BY-LAW OF THE MUNICIPALITY OF QUISPAMSIS RESPECTING SIGNS

**BE IT ENACTED** by the Council of the town of Quispamsis that By-law No. 036; A By-law of the Municipality of Quispamsis be amended as follows:

1. By immediately after Section 2. A. **Definitions**, deleting in its entirety definition (50.1) "Traffic Control Device" and replacing with the following:

(50.1) "Traffic Control Device" shall be defined herein as found in the Motor Vehicle Act of New Brunswick and shall include Traffic Roundabouts, Traffic Control Islands, Traffic Circles and the associated signage required to direct traffic at the intersections set out in Schedule "L" as found in the town of Quispamsis Bylaw Number 27 - A Bylaw of the town of Quispamsis Respecting Traffic on Streets and Public Places.

2. By adding immediately after Section 3. D, **Signs Permitted in All Zones**, Paragraph (1) (g) (iv).; the following:

(v) Are not located within five (5) meters of, or within the inside island of an intersection with traffic control islands as defined by this By-law and as found in the town of Quispamsis Bylaw Number 27, A Bylaw of the town of Quispamsis Respecting Traffic on Streets and Public Places.

3. In Section 3. E. Signs Prohibited in All Zones

In section (14) By deleting "...and shall be located at least five (5) meters from a traffic control device..."

And replacing it with "...and located within five (5) meters or less of a traffic control device..."
