



TOWN OF QUISPAMSIS PUBLIC NOTICE PROPOSED BY-LAW AMENDMENT NO. 027-36; A BY-LAW OF THE MUNICIPALITY OF QUISPAMSIS RESPECTING TRAFFIC ON STREETS AND PUBLIC PLACES

Public Notice is hereby given that the Quispamsis Town Council intends to consider enacting By-law Amendment No. 027-36; A By-Law Of The Municipality Of Quispamsis Respecting Traffic On Streets And Public Places.

The proposed Traffic By-law has been updated to include:

- language that restricts signs being placed in "Traffic Control Devices" like a Traffic Roundabouts, Traffic Control Islands, Traffic Circles.
- A reduction of speed on Aurora Boulevard from 50 km/hr to 30 km/hr

The proposed By-law Amendment No. 027-26 received first and second reading at the April 15, 2025 Regular Meeting and third and final reading will be considered by Council at the May 6, 2025 Regular Meeting which begins at 6:00 p.m., and is held in the council chambers of the Quispamsis Town Hall, 12 Landing Court, Quispamsis, New Brunswick.

The proposed amendment may also be inspected by any interested person during regular office hours, 8:00 a.m. to 4:30 p.m., Monday to Friday inclusive, at the Quispamsis Town Hall, 12 Landing Court, Quispamsis, New Brunswick.

AMENDMENT NO. 27-36

TO BY-LAW NO. 027 A BY-LAW OF THE MUNICIPALITY OF QUISPAMSIS RESPECTING TRAFFIC ON STREETS AND PUBLIC PLACES

BE IT ENACTED by the Council of the town of Quispamsis that By-law No. 027; A By-law of the Municipality of Quispamsis be amended as follows:

1. By adding immediately after Section 4, TRAFFIC CONTROL DEVICES, add the following after paragraph (3):

(4). Traffic Roundabouts, Traffic Control Islands, Traffic Circles and the associated signage required to direct traffic at these intersections shall be constructed and maintained at the locations set out in Schedule "L"

2. By adding immediately after Schedule "K", the following:

Schedule "L" Intersections with Traffic Control Islands

- 1) The intersection of Squire Drive, Alma Lane and Route 119. (Gondola Point Arterial)
- 2) The intersection of Southwood Drive and Hardwood Crescent.
- 3) The intersection of Queensbury Drive and Lexington Drive
- 4) The intersection of Queensbury Drive and Grasmere Avenue and Cambridge Avenue
- 5) The intersection of Gondola Boulevard and Laura Drive
- 6) The intersection of Gondola Boulevard and Leah Boulevard and Jenkins Drive
- 3. By adding immediately after Schedule "C" 18., the following:

19. Aurora Boulevard in its entirety from the intersection of Vincent Road to the intersection with Chelsea Drive.
