**ADMENDMENT NO. 053-01
TO PLANNING ADVISORY COMMITTEE BY-LAW NO. 053
A BY-LAW OF THE MUNICIPALITY OF QUISPAMISIS RESPECTING THE
PLANNING ADVISORY COMMITTEE**

BE IT ENACTED by the Council of the Town of Quispamsis that By-Law No.053; A By-law of the Municipality of Quispamsis, pursuant to Section 3 of the *Community Planning Act of New Brunswick*, is hereby amended as follows:

1. *By replacing the section immediately following the Title of the Bylaw with the following:*

A By-law of the town of Quispamsis, entitled By-law No. 053, A By-law to Establish a Planning Advisory Committee, is hereby enacted under authority vested in it by Section 3 of the Community Planning Act, SNB 2017 chap. C-19, as follows:

2. *By replacing Section 4 and 5 with the following:*

4) Members of the Planning Advisory Committee who are not members of Council shall receive the payments and reimbursements set out in Quispamsis Policy No 052 the Allowance and Reimbursement Policy for Non-Council/Non staff members serving on Town Committees, Boards & Commissions as amended from time to time.
